#### 6 **Part A: Establishment and Location**

##### 8 1.A.1 Constitution of 1876

10 The University of Colorado was originally established as a territorial university by act of  
11 the Council and House of Representatives of the Colorado Territory on November 7,  
12 1861. Upon Colorado's admission to the Union in 1876, the Constitution of the State of  
13 Colorado declared the territorial institution of the "University at Boulder" to be an  
14 institution of the State.

##### 18 1.A.2 Constitutional Amendments of 1923

20 Section 5 of article VIII of the State Constitution was amended in 1923 to authorize the  
21 Regents of the University to operate all or any part of the departments of medicine,  
22 dentistry, and pharmacy at Denver. Also, nothing in section 5 was to be construed to  
23 prevent the university or other state educational institutions from giving temporary  
24 lecture courses in any part of the state, or conducting class excursions for the purpose of  
25 investigation and study.

##### 27 1.A.3 Constitutional Amendments of 1972

29 In 1972, section 5 of article VIII of the State Constitution was further amended to:

- 31 (A) describe the university as being "at Boulder, Colorado Springs, and Denver";
- 33 (B) extend the University of Colorado Anschutz Medical Campus provision to include  
34 all or any part of the schools of medicine, dentistry, nursing, and pharmacy of the  
35 university, together with hospitals and supporting facilities and programs related to  
36 health; and
- 38 (C) make clear nothing in section 5 was to be construed to prevent any state institution  
39 of higher education, with prior approval of the General Assembly, from  
40 "establishing, maintaining, and conducting or discontinuing centers, medical  
41 centers, or branches in any part of the state."

43 1.A.4 Location and Administration of Four Campuses  
44

45 The University of Colorado shall consist of a president's office and four campuses, each  
46 of which shall be headed by a chancellor. The campuses shall operate at several  
47 principal sites located and referred to as follows:

- 49 (1) at Boulder, "the University of Colorado Boulder";  
50 (2) at Colorado Springs, "the University of Colorado Colorado Springs";  
51 (3) at Denver, "the University of Colorado Denver";  
52 (4) at Aurora, "University of Colorado Anschutz Medical Campus."
