5 **Part B: Meetings**

7 2.B.1 Regular, Special and Committee Meetings

- 8  
9 (A) Regular meetings of the Board of Regents shall be held in accordance with the  
10 schedule of meetings approved annually.  
11  
12 (B) Special meetings may be called by the chair or by the president and shall be  
13 called by the chair upon the request of three board members. A special meeting  
14 may be convened only to consider the item(s) of business specified in the  
15 meeting notice.  
16  
17 (C) Committee meetings shall be held at dates and times that the committee  
18 specifies.  
19  
20 (D) Notice of regular and special board and committee meetings shall be posted as  
21 provided in board policy.

25 2.B.2 Meetings Open to the Public

27 (A) All regular, committee, and special meetings of the Board of Regents at which  
28 public business is discussed or formal action may be taken, including the  
29 adoption of any proposed policy, resolution, rule or regulation, shall be open to  
30 the public in compliance with state open meetings requirements, provided that  
31 the Board of Regents and its committees may meet in executive session for  
32 purposes authorized by law.

33  
34 Open meeting requirements include, but are not limited to, posting a full and  
35 timely notice prior to the meeting and taking minutes of the meeting and making  
36 available for public inspection.

37  
38 These requirements apply to all meetings to conduct public business, whether in  
39 person, by telephone, electronically or by other means of communication.

43 (B) All meetings of two or more regents at which public business is discussed or at  
44 which any formal action may be taken is a public meeting. Social gatherings or  
45 other chance meetings at which the discussion of public business is not the  
46 central purpose do not constitute public meetings.

48 2.B.3 Meeting Procedures  
49

50 (A) The Board of Regents acts only at public meetings called in accordance with the  
51 state open meetings requirements and board laws and policies.  
52

53 (B) *Robert's Rules of Order Newly Revised* will apply to procedure at meetings if the  
54 Laws of the Regents or regent policy do not specify otherwise.
