- Family & Medical Leave Insurance Act (Slide deck)
- Open to all employees including temps and students
- This was part of state law
- Starting Jan 1, .45% of salary will go towards this- there is no opt-out at this time.

#### Discussion:

- Confusion on percentage- clarified to .45%
- Education on this will be key- HR staff are lean and prior implementations have not been consistent or well done because of timing and capacity.
- What happens if the pool goes bankrupt? Deductions are building for a year before benefit is implemented.
