It's exciting — the launch is almost here! The CU Marketplace Redesign launches on Thursday, October 17, 2024. Time is running out, and we want to make sure you're fully prepared. Please review the must-know points below and take any necessary action. Be sure to register for our final webinar and post-go-live, hands-on training sessions on campus. ## 1. Must-Know Points: Action Required

- **Non-Urgent SPO Submissions-** We strongly encourage you to delay any non-urgent SPO submissions until October 17th. Any pending SPOs run the risk of needing to be resubmitted using the new form.
- **Requisitions and Payment Vouchers in Your Cart** - If you have any requisitions or payment vouchers in your cart, they must be submitted before **3:00 pm on October 16th**. Otherwise, you will need to resubmit them using the new form on October 17th.
- **Requisitions Approved After 3:00 p.m.** - Any requisitions approved after **3:00 pm on October 16th** will be put on hold and will not go to the supplier until October 17th.
- **Requisitions Returned or Rejected After October 16th-** If your Approver returns or rejects a requisition on the old form, it will need to be resubmitted on the new form.
