Regent Laws and Policies (RLPs)

Laws of the Regents ^[7]: enacted by the Board of Regents, the highest source of authority within the university, establish how the university is organized and governed.

Regent Policies ^[8]: enacted by the Board of Regents to operationalize the Laws of the Regents, direct the operation of functions the board is responsible for, and delegate authority to officers of the university and the administration.
